# PROVIDE OPPORTUNITY

**Washington's independent colleges serve an economically diverse student body:**

Over 20% of resident undergraduates receive the State Need Grant and about 25% of undergraduates are awarded the Federal Pell Grant.

The majority of financial aid to low-income students is in the form of grants.

# 90%

**of students receive institutional aid**

This investment from the college averages about \$13,000 per student, and totals over \$275 million.

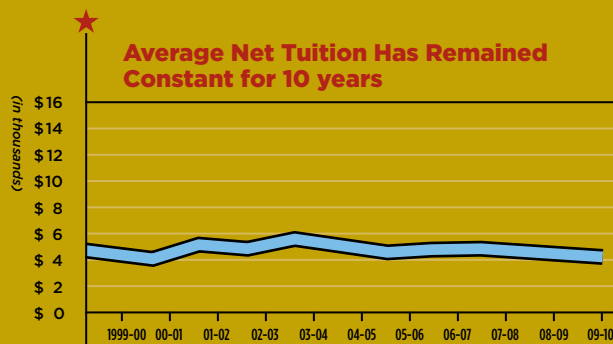

Independent colleges receive less than 2% of the state higher education budget, all in the form of student aid, yet deliver nearly 25% of degrees.

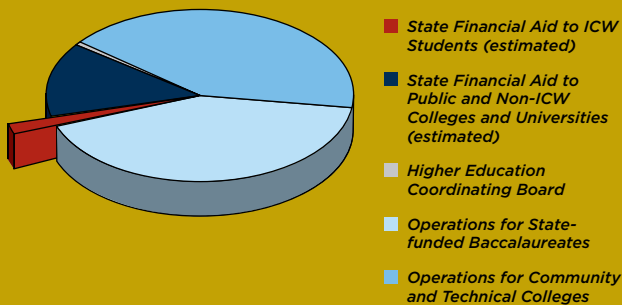

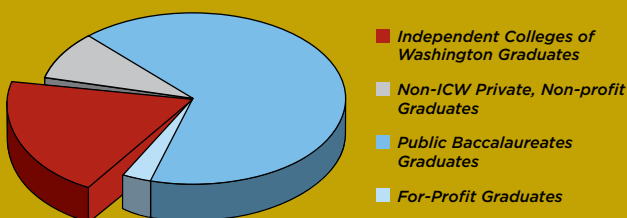

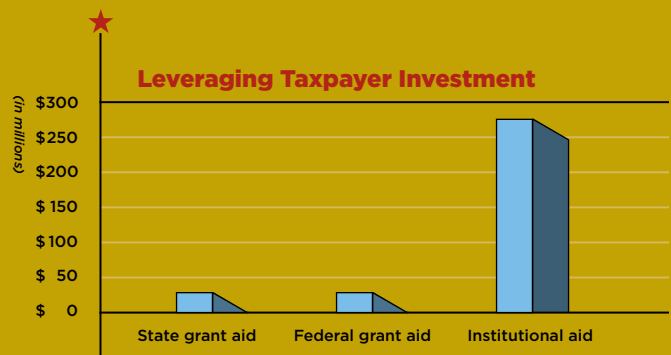
State Higher Education Budget, 2010-11 Supplemental

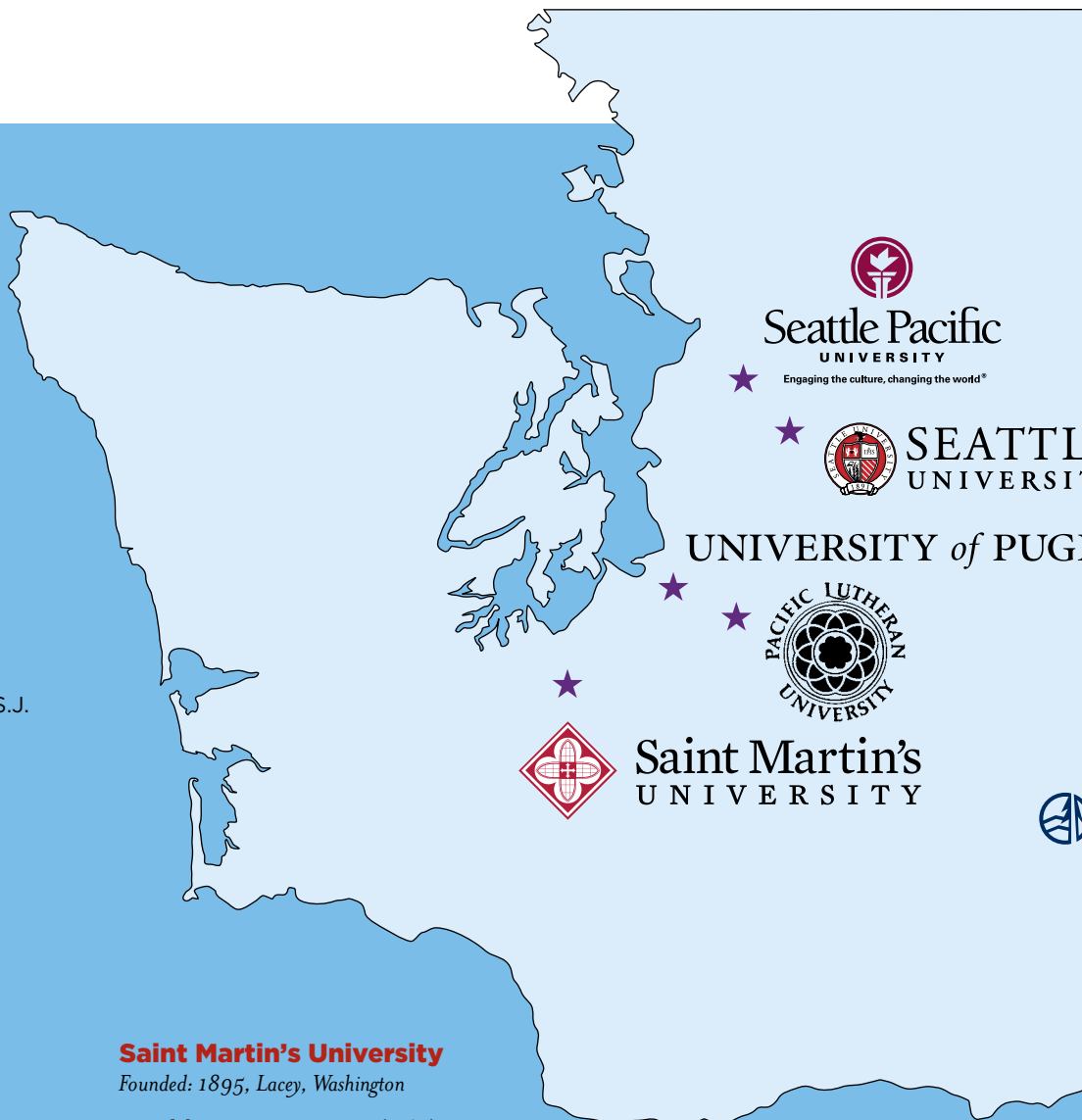

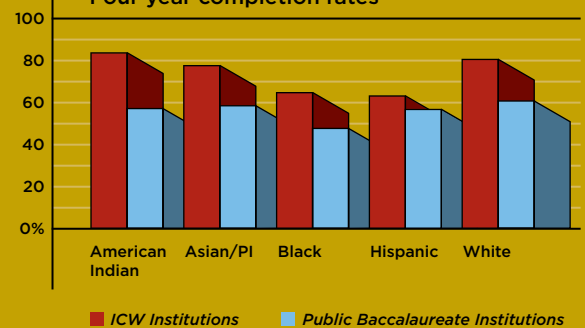
